

Community Safety Policy

1. <u>Aim</u>

The aim of this policy is to state Totton and Eling Town Council's approach to Community Safety, which includes tackling anti-social behaviour.

2. Scope

Community Safety includes operation and enforcement, gathering of intelligence and community safety interventions by various multi-tasking local and government agencies.

Community Safety is a generic term and includes anti-social behaviour, crime and disorder. Under s.17 of the Crime and Disorder Act 1998, Totton and Eling Town Council has a duty to exercise its various functions with due regard to the likely effect on crime and disorder in its area of jurisdiction.

3. Authorisation

In order to combat crime within a designated area, powers of enforcement have been granted to authorised officers under the Police Reform Act 2002 and in accordance with the Safer New Forest Strategic adopted by New Forest District Council and in line with partnerships policies and procedures of Hampshire Constabulary.

4. Council

Totton and Eling Town Council's constitution, allows the Executive Management Team the duty to appoint officers with suitable qualifications, experience and level of competency to enforce, or to, ensure that appropriate officers are trained to the required level to undertake an enforcement role.

Authority to exercise functions in relation to Community Safety has been delegated to the Community Warden as detailed in Council's constitution.

5. **General Principles**

When carrying out the functions relating to Community Safety, it is important that Council works within the statutory framework set out by Government and that it follows best practice and procedures.

In particular, the Council is committed to acting in a fair and consistent manner and has adopted this Community Safety policy as part of this commitment. When exercising its functions, the Council will act in such a way which is:-

- transparent
- o accountable
- o proportionate
- o consistent
- o targeted only at cases in which action is needed.

7. Interventions and Enforcement

Totton and Eling Town Council adopts a robust stance in tackling anti-social behaviour and associated issues, as feeling safe in the community is frequently cited as one of the main issues for citizens been affected in our community and making the Town a safer place to live, work and visit.

In all investigations the emphasis will be on achieving a speedy resolution which is acceptable to all parties without the need to pursue legal remedy.

Whilst Totton and Eling Council Community Safety Team do not have the powers of arrest, the Community Warden works closely with the police and all investigations relating to matters covered by this policy are jointly investigated which enables the full range of available enforcement powers to be utilised, including arrest.

After considering all relevant information one or more of the following courses of action could or may be taken:

- no action
- o informal action (verbal or written)
- o fixed penalty notice
- o seizure
- o caution
- prosecution
- injunction
- premises closures
- alley gating
- drink banning order
- o anti-social behaviour order
- dispersal area notices

Not all of these options are available in every case. This underlines the need to consider powers available under each piece of legislation individually.

In making any decision on enforcement, officers will consider the following criteria:-

- o the seriousness of the offence
- the offender's past history
- o consequences of non-compliance
- o the known or likely public benefit of the chosen enforcement action
- the willingness of the offender to prevent a recurrence and in the case of a business, the confidence in management
- the likely ability of any witnesses to give evidence and their willingness to cooperate with the authorities
- o the Crown Prosecution Service's Code of Practice for Crown Prosecutors

8. Policy Monitoring

To ensure compliance with this policy, the activities of the Community Safety Team will be monitored by the Hampshire Constabulary and the Executive Officer of the Totton and Eling Town Council.

This policy will be reviewed annually by the Executive Officer of Totton and Eling Town Council.

9. Training and Development

Appropriate resources will be made available for training for officers to enable them to successfully carry out their duties within this policy.

10. Equality Impact Assessment

This policy falls within the Overarching Enforcement Strategy Equality impact assessment of Totton and Eling Town Council.
