Successful bid to expand the Community Orchard at Bartley Park funded through HCC scheme was confirmed, and planting has been completed. This will provide stabilisation for a bank area, and wildlife corridor. Planting of disease resistant Elm trees across the Town has also now taken place. In total 766 trees were introduced in the last planting season, via community planting supported by volunteer groups. Box tree moth issues have been

			<p>addressed and replaced with Green Spire plants. 8275 plug plants, including wildflower and oxide daisy, together with 4,137 grammes of yellow rattle seed have been planted at Batley Park Meadows. Additionally, 21 new trees have been planted at Cheam/Testwood Recreational area as part of the NFDC Mitigation programme. Daffodil bulbs have been planted around the pond area in the Town Park for bloom in spring 2026.</p>

Funding obtained from NFDC and bird boxes, bat boxes and bug houses have been situated around Council facilities and additional bat boxes, and insect houses have been donated to schools for inclusion in curriculum, thus promoting nature education and awareness for young people. Proposals have gone to Council for increasing the planting budget, thus enhancing insect travel/recovery. Installation of</p>

			<p>hedgehog houses at Council facilities, and via schools' competitions in the next half term for residential garden positioning, has commenced and will enhance hedgehog travel in the Town. Friends of Bartley Park have taken on the construction and placement of hedgehog boxes in the Park. Additionally, Communications with ARK (Amphibian and Reptiles Conservation Trust) regarding 'refusers' (TINS) has commenced to assist the monitoring of reptiles. On-going.</p>
